ORDER

In the circumstances reported by the Director of Census Operations, AP Hyderabad in her letter 1st read above, sanction is hereby accorded to the Director of Census Operations, AP Hyderabad to incur an expenditure of Rs.48,26,81,300/- (Rupees Forty eight crores, twenty six lakhs, eighty one thousand and three hundred only) towards payment of Honorarium and Training Allowance to the Enumerators, Supervisors and Master Trainers and also Honorarium to the Census functionaries, i.e. Charge Officers and Principal Census Officers at Charge and District level, in connection with the Housing Census and House-listing Operations in the State of Andhra Pradesh as per the details specified in Annexures – I, II and III to this order, from out of the Budget amount of Rs.9144.51 lakhs released vide the reference 3rd read above.

2 The expenditure towards payment of Honorarium and Training allowance for Census work sanctioned in para above shall be debited to “MH-3454 –Census, Surveys and Statistic-01-Census- MH-800-other expenditure-S.H.(05)-Census Estt- 2011-280/284-Other Payments.”

3. The Director of Census Operations, AP Hyderabad shall draw and disburse the amount sanctioned above through PD Account No.297 to the District Collectors/Commissioners of Municipal Corporations in the State as specified in the Annexures – I, II and III to this order.

4. On drawal and disbursement of amounts, the District Collectors and Municipal Commissioners are requested to furnish the consolidated particulars to the General Administration (Accom.A.2) Department and to the Director of Census Operations, Andhra Pradesh, Hyderabad along with Utilization Certificate so as to reconcile the expenditure with the Accountant General, Andhra Pradesh, Hyderabad.

5. The Director of Treasuries and Accounts, Andhra Pradesh, Hyderabad is requested to authorize the expenditure immediately and ensure that the Pay & Accounts Officer concerned admit and honour the bills without any delay.
