All the Deputy Educational Officers in the district are informed that the tentative seniority list of School Assistants / Gr.I Language Pandits working in Zilla Parishad & Govt. Schools in the district separately for Govt. / Z.P. has been prepared as per the material available in this office.

They are requested to verify the said tentative seniority lists with the service registers of the individuals and called for objections from them. After making modifications and corrections, the rectified seniority list should be submitted to the undersigned in Hard and Soft copies on or before 22.11.2011 without fail.

- 1 School Assistants of Govt. & Z.P. separately.
- 2 School Assistants Telugu Pandits, Hindi Pandits & Sanskrit Pandits who are having B.Ed. qualifications Govt. & Z.P. separately.
- 3 School Assistants Telugu Pandits, Hindi Pandits & Sanskrit Pandits who are not having B.Ed. qualifications Govt. & Z.P. separately.  
(As G.O.Ms. No. 20 School Education (Ser.II) Department dated. 27.01.2009 issued orders that the School Assistants / Language Pandits who possessed SSC / HSC/ MPHSC, Intermediate and later obtained the oriental title degree after further studies of 5,4,3 years after SSC/HSC/Intermediate respectively and possessed Pandit Training are eligible for Promotion to the post of Gazetted Headmaster Gr.II. The School Assistants / Language Pandits who possessed oriental title and pandit training subsequently acquired lower qualification of SSC / HSC / Intermediate are not eligible for promotion to the post Gazetted Headmaster. Gr.II.)
- 4 L.F.L. Headmasters working in Primary Schools who are having B.Ed. qualifications and qualified to hold the post of H.M. / M.E.O.
- 5 Physical Directors who are acquired relevant qualifications for the post of Headmasters Gr.II.

Hence, the tentative Seniority Lists of above categories are herewith communicated to the Deputy Educational Officers concerned. They are requested to obtain any changes in the Seniority Lists. Further, they are also requested to obtain the changes or appeals if any from L.F.L HMs / School Assts working in UP Schools and to clearly specify the following cases in the seniority lists of the individuals if any.
